



# Race the Wrecks

## 2017 LSYC MAST Race July 1<sup>st</sup>, 2017 Notice of Race and Event

**Course:** Up to a 22 mile triangle, weather dependent, upon the waters of Lake Erie, starting and finishing at the port of Lorain and including the MAST marks for wrecks *Morning Star* and *Hickory Stick*. Marks are placed and maintained by the Maritime Archaeological Survey Team (MAST) over these wrecks and many others in the area. **Classes:** PHRF-Spinnaker and PHRF-JAM. Classes will be combined into only JAM if insufficient boats register in both classes by Saturday June 24. We will also hold a predicted log for powerboats if we get at least 3 boats registered

**Awards:** Awards by class presented at the annual Club "July Forth All American Picnic" that evening. Time-handicap scoring based upon your PHRF-LE rating certificate. Boats without a certificate will be assigned a rating by the race committee. Only first place awarded if fewer than five boats registered in a class.

**Party:** Join us afterwards at the LSYC clubhouse for the club's annual picnic and then stay for a front-row seat of the city of Lorain's Fireworks show. Picnic RSVP under separate cover. Make it a full night of fun at LSYC!

**Rules:** This race is governed by the 2017-2020 US Sailing Rules (RSS) unless amended by the Sailing Instructions. Amendment deadline is the end of the skippers meeting.

**Dockage:** Non-LSYC dockers will be provided complimentary dockage before and after the race at LSYC.

**Register:** Race registration closes at 17:00 on Thursday June 29, 2017.

- Corrected time based on PHRF-LE rating for your class (Spinnaker or JAM)
- Registration fee includes race costs and awards. Add in dinner tickets for the post-race dinner and party.

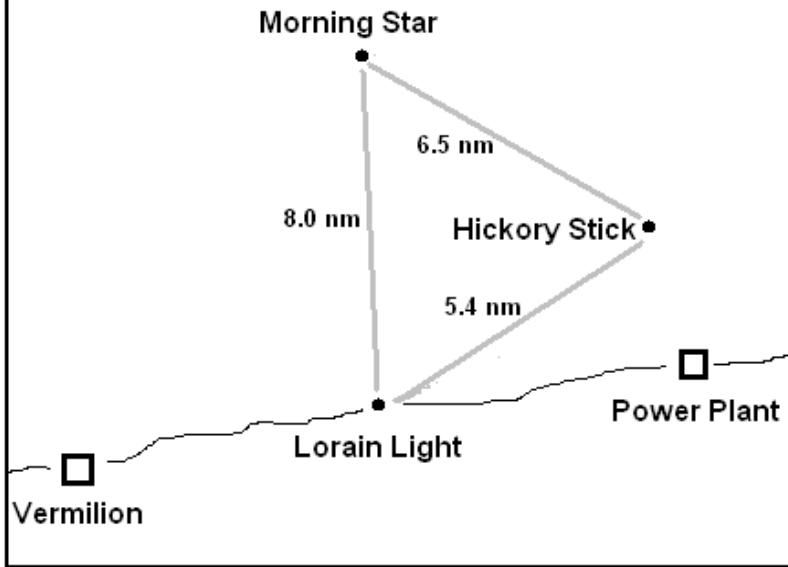

## RACING WAIVER AGREEMENT
