



LSYC Tom Gibbs Memorial Kelleys Island Race August 25-26, 2018 Notice of Race

- Course:** Port of Lorain to Kelley's Island and return with half-way overnight stay on Kelleys (Seaway Marina). Distance 25.6 nm/leg. No marks and no time limit. Starts may be a rabbit start – see Sailing Instructions
- Classes:** PHRF-Spinnaker and PHRF-JAM. Classes may be combined into JAM if insufficient boats register in either class.
- Awards:** Awards by class. "Half-way" awards distributed Saturday night at the party. Overall awards distributed at LSYC Fall Clam Bake.
- Party:** There will be a mid-course steak fry with the trimmings held at a picnic pavilion at Seaway Marina on that Saturday night. You must register by August 20 to guarantee steak/chicken meals.
- Rules:** This race is governed by the 2017-2020 US Sailing Rules (RSS) unless amended by the Sailing Instructions.
- Scoring:** Overall awards based upon shortest round-trip, corrected, elapsed time using fastest Sunday leg time as a tie breaker. If using pursuit starts then finish order.
- Dockage:** We have eight (8) dock slots reserved at Seaway Marina for Saturday night but extra room will be found. Dockage fees are \$2/foot and are the responsibility of each skipper. A count of docks needed will be taken thru the race registration.
- Register:** Race registration closes by 17:00 on Monday, August 20, 2018.
- Corrected time based on PHRF-LE rating for your class (PHRF or JAM)
 - Registration fee includes race costs and awards. Add Steak Fry count too.
 - Late registrations are not guaranteed a Seaway dock or Steak Fry food.

RACING WAIVER AGREEMENT

2.
